Problem Statement

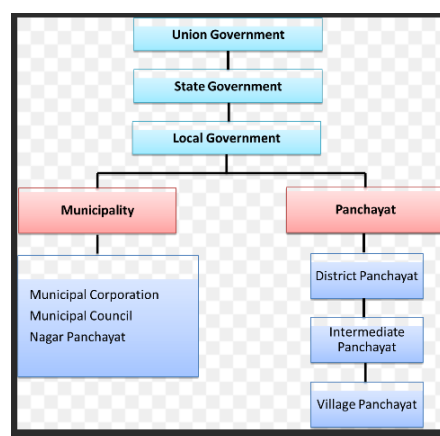
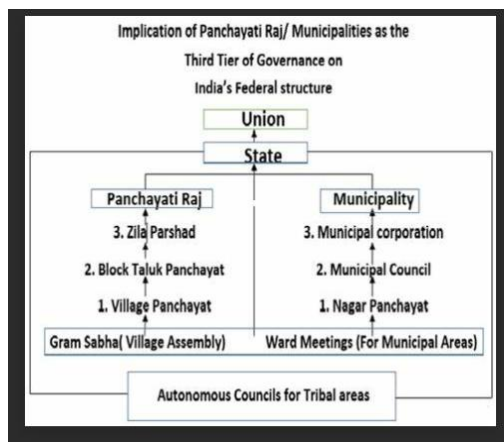

What are intergovernmental relations & why they important?

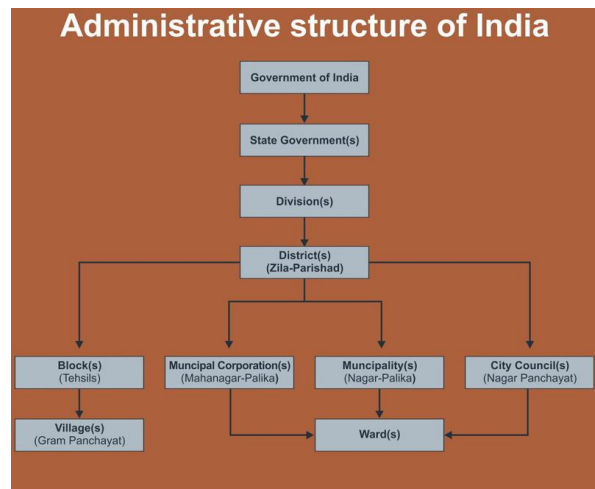

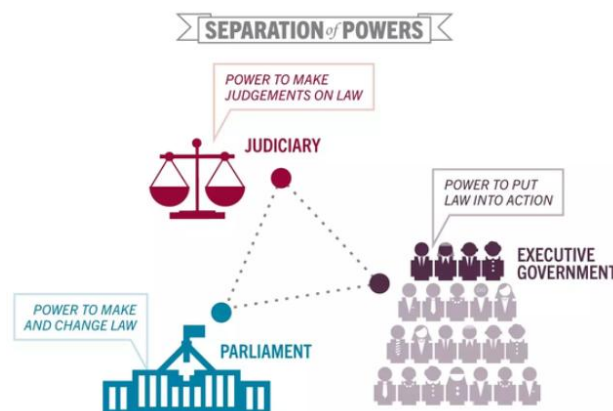
Nature of Relationship between Local Government and Other Levels of Government

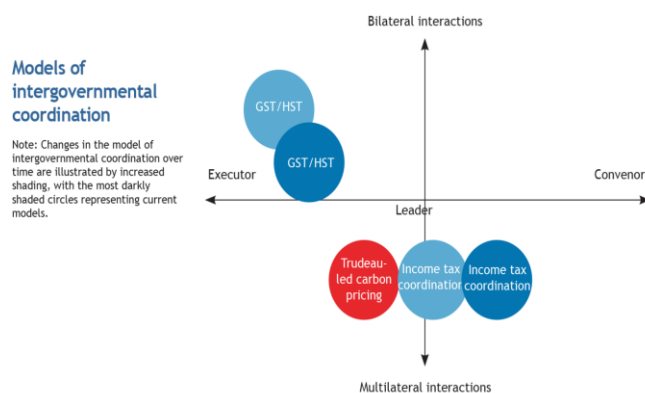

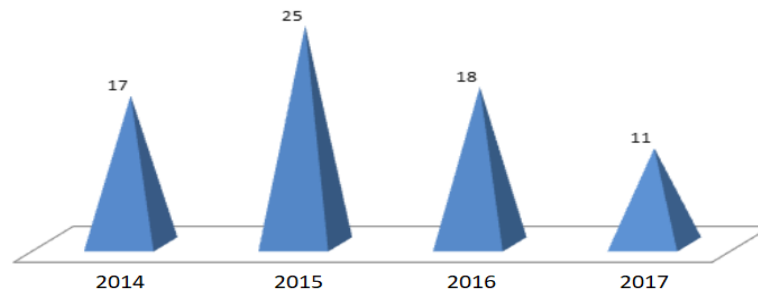
